Context:

This report presents the implementation of LEED 62 Batch in tehsil & District Layyah. The basic objective of the project is to delivered and strengthen the Common interest groups, Production centers, NYKs, Youth Centers Capacitate them and lift up their lives. Different activities has been completed under the LSOs which will reflect in the Project Completion report.

LEED Project: LEED is a PPAF supported initiative which aims at targeting ultra-poor and vulnerable households to enable them to enhance productivity of ultra-poor through focused interventions aimed at developing skill sets and assets for greater income generating opportunities and better livelihood. Under the LEED Project batch 62, ADO trained 593 persons on varied trades/skills, provided productive assets to 333 beneficiaries, developed two, formed 09 Common Interest Groups (CIGs) and organized one mega event (District Mela). In addition to this, ADO consolidated the documentation and case studies for best practices in livelihood enterprise development. This project was implemented for a period of 06 months from April to September 2015. This project was implemented in five union councils of tehsil Layyah in district Layyah.

Area Profile

In 1901, Layyah was transferred to the new District of Mianwali. Later on, it was made part of the Muzzaffargarh District. In 1982, Layyah Tehsil was upgraded to District headquarters comprising three Tehsils: Layyah, Karor Lal Eisan and Chaubara. The municipality was created in 1875. The population, according to the 1998 census was 2 Million.

The district name is derived from a commonly grown shrub, 'Layyan' (Tamarisk dieica) used as fuel wood which covered the area at one time. District Layyah is situated in the south west (rather west) of Punjab. In its north, is situated the district of Bhakkar while in its west flows River Indus. Across the river there is Dera Ghazi Khan which is also the district of Punjab. District Jhang is located in the east and Muzaffargarh is located in the south of district Layyah. Layyah declare as poorest District of Punjab.

Landscape and Physical Features of the Area

District Layyah lies between 30-45 to 31-24 deg north latitudes and 70-44 to 71 -50 deg east longitudes. The district consists of a semi-rectangular block of sandy land between the Indus and Chenab rivers in Sindh Sagar Doaba. It is also a part of the recently established civil division of Dera Ghazi Khan. The total area covered by the district is 6,291 sq. km with a width from east to west of 88 km and a length from north to south of 72 km. Having a population of 1,121, 951, the population density is 178.2 people/sq km.

The climate of the district varies from very hot in summers to cold in winters with the highest temperature of above 42 degree centigrade in June and lowest up to 4 degree in January. The district receives only scanty rainfall, the average rainfall does not exceed 18.7 centimeters which is mainly in the monsoons (July-August), although some exceptions have occurred occasionally in the past e.g. in 1980-81, it was as high as 54.4 centimeters¹. It is evident from the same source that there has been an overall declining trend in the frequency and quantity of rainfall in the district over a period of several decades (ibid, pp.5 and 6). However, heavy rains in anywhere above the district, result in floods in the Indus river.


These floods cause huge disasters especially in the Nasheb areas along the river banks (from the North West to south west of the entire district). The high floods during the monsoon months this year and the year before, affected more than 100,000 people. There was loss of human lives, livestock and crops. A lot of land eroded, leaving many without homes (Oxfam flood reports July18, 2005 and July 19, 2006).

Settlement Patterns:

The settlement pattern in the district is influenced by the geography and agro-ecological setting. Relatively large and nucleated villages are located in the fertile and irrigated areas which are mainly in the Thal tract where agriculture has been developed extensively. In 'Nasheb' which is the low lying area, inundated occasionally by the River Indus, relatively smaller, scattered and rather temporary or semi-permanent human settlements have been possible.

The same trend is found in the sandy desert areas of the district with smaller, scattered and humble

habitations of nomadic and semi-nomadic population. The Chaubara Tehsil, which is largest in respect of the total area and minimum in terms of population, with a minimum percentage of people/Km, is a typical example of small human settlements as the local ecology cannot




support large human concentrations at any given place in this Tehsil.

Administrative Sub-divisions

District Layyah has three sub-divisions or Tehsils:

- 1) Layyah
- 2) Karor Lal Esan
- 3) Chaubara



Tehsil Layyah is situated at the south west of the district along the River Indus, the latter separating it from Dera Ghazi Khan District. Karor Tehsil is located just above the Layyah Tehsil along the right bank of the Indus and Chaubara is in the north west of this district and is the largest of all the three Tehsils, covering most of the eastern half of the district area.

There are three Municipal committees and one Town committee in the district. There are about 200 Patwar circles or land recording and revenue units. The number of Mauzas or the smallest revenue units in the district is about 730. Of the latter, only 26 have a population of above 5000 and about 53% of Mauzas have less than one thousand people while others have between one to two thousand people (District Census 1998-op.cit).

Industry Situation:

The only 'large scale' industry in the district is the Layyah Sugar Mill established in 1954. This mill provides employment to a few thousand people, mainly as workers or laborers in the district. Although not mentioned by the District Census 1998, cotton ginning and pressing, oil pressing mills are medium and small level industries in the district.

Besides the sugar mill, there are three large flour mills with modern equipment in the district and many small 'Chakkies' in urban and rural areas (District Census; 1998)



<u>Project objectives and</u> approaches:

The objective of project is to develop the capacity, opportunities, assets and productivity of community to reduce their vulnerability to shocks, improve their livelihoods initiatives strengthen their business operations by mapping and need assessments of livelihood related skills, knowledge and practices for the deprived Community.

Livelihood Frame work



Concept of Sustainability: A livelihood can be classified as sustainable, when it is resilient in the face of external shocks and stresses, when it is not dependent upon external support,

when it is able to maintain the long-term productivity of natural resources and when it does not undermine the livelihood options of others.

Target Area

Livelihood interventions made in the areas identified as target areas for ADO supposed to work in their existing villages and union councils, which have been organized into Community institutions and benefited from planned interventions.

2. Poverty Targeting

Proper identification of the various target groups is crucial to ensuring an inclusive approach to livelihood development. The ultra-poor, chronically poor and transitory poor households will be identified through the Poverty Score Card' and the social mobilization process is designed in a way that inclusion of all the segments of the particular community is actively pursued. The vulnerable groups will be identified through various participatory appraisal methods and validated through door to door surveys. ADO ensured that all types of poor benefit from the interventions made under the livelihood component. Due to a number of reasons it may not be possible for the ultra poor to participate in the activities like inter loaning, however efforts would be made to enable them to participate in such activities through assets transfers and other activities focused on such segments. Similarly ADO will facilitate its COs to link with the safety net programmes being implemented nationally. For this purpose, data collected through Poverty Score Card will be used for linking the ADO target groups with such initiatives, until they graduate to higher tiers of social strata to benefit from the inter-loaning activity and are credit worthy clients of financial institutions.

In LEP context vulnerable poor is defined as a person falling under poverty line as per the Poverty Score Card and having following additional characteristics:

- i. Widows having no male child of over 18 years of age
- ii. Women with disabled husbands
- iii. Abondonded women, elderly and children
- iv. Girls having crossed the age of marriage and dependent on others
- v. Orphans without legal guardians
- vi. Person with disabilities
- vii. Person over age of 60 having no male child over age of 18
- viii. Person adversely effected by natural and human made disaster

Social mobilization is the bedrock of ADO interventions and the process is designed in a way that inclusion of all the segments of a particular community is ensured. The data collected through the poverty score card will be shared with the community organizations and their endorsement will be obtained in order to ensure transparency and ownership of the process as well as authenticity of the information collected. This will also help in averting intra-community conflicts with regards to transfer of benefits to the target group.

INTRODUCTION

1.1 Context

Awami Development Organization (ADO) has recently completed Livelihood Employment & Enterprise Development (LEED) Project in five union councils of tehsil & district Layyah. LEED is a PPAF funded initiative which aims at provision of a range of livelihoods interventions, extends capacity building and initial grant funds to incubate social enterprises and ensures that it is set up and managed on sustainable business principles. This project has completed its 6-month phase in September 2015. In order for assessing the immediate after-implementation impact of project activities/interventions, the current study was initiated in the month of November 2015 almost 2 months after the completion of project targets/activities. This preliminary stage assessment will help ADO in terms of digging out field realties of its various livelihood support and poverty alleviation programs in the target communities looking into how the process of poverty graduation is proceeding.

1.2 About LEED Project:

LEED is a PPAF supported initiative which aims at targeting ultra-poor and vulnerable households to enable them to enhance productivity of ultra-poor through focused interventions aimed at developing skill sets and assets for greater income generating opportunities and better livelihood. The LEED Project was born out of the necessity to find innovative, sustainable and scalable strategies so that people living in poverty and those living in extreme poverty can stabilize themselves socioeconomically, increase their resilience to shocks, and continue on the path to development through accumulating productive, financial, human and social assets. PPAF, under its Livelihood Employment & Enterprise Development (LEED) Group initiatives since 2013, has been playing a key role in graduating those households that are below the poverty line through two-pronged strategy of 'push and pull'. The group specializes in provision of a range of livelihoods interventions, extends capacity building and initial grant funds to incubate social enterprises and ensures that it is set up and managed on sustainable business principles. Besides, it supports advocacy efforts to change policy that may have a positive influence for community-based livelihoods.

Under the LEED Project batch 62, ADO trained 593 persons on varied trades/skills, provided productive assets to 333 beneficiaries, developed two digital hubs, formed 09 Common Interest

Groups (CIGs) and organized one mega event (District Mela). In addition to this, ADO consolidated the documentation and case studies for best practices in livelihood enterprise development. Along with this series of exposure visits were organized for experience sharing and mutual learning. Additionally, ADO's team focused on developing market linkages. This project was implemented for a period of 09 months from January to September 2015. This project was implemented in five union councils of tehsil Layyah in district Layyah. The main criterion for selection of project beneficiary households was based on scores obtained on Poverty Score Card (PSC) which was applied at the start of the project interventions. The complete PSC database of all the 593 direct beneficiary households was developed.

Project Objectives and Approaches:

The objective of project is to develop the capacity, opportunities, assets and productivity of community to reduce their vulnerability to shocks, improve their livelihoods initiatives strengthen their business operations by mapping and need assessments of livelihood related skills, knowledge and practices in union council existing two union councils and two new union councils was also added on the basis of HID project need and identification.

The ultra-poor, chronically poor and transitory poor households will be identified through the Poverty Score Card' and the social mobilization process is designed in a way that inclusion of all the segments of the particular community is actively pursued. validated through door to door surveys. ADO ensured that all types of poor benefit from the interventions made under the livelihood component. Due to a number of reasons it may not be possible for the ultra poor to participate in the activities like inter loaning, however efforts would be made to enable them to participate in such activities through assets transfers and other activities focused on such segments. 2. LEED & Social Mobilization

Social mobilization is the bedrock of ADO interventions and the process is designed in a way that inclusion of all the segments of a particular community is ensured. The data collected through the poverty score card will be shared with the community organizations and their endorsement will be obtained in order to ensure transparency and ownership of the process as well as authenticity of the information collected. This will also help in averting intracommunity conflicts with regards to transfer of benefits to the target group.

3. The Poverty Score Card

At the very beginning an identification survey has been conducted. 9685 households were door to door visited by the field teams in previous phases. The prime objective of the survey is to identify Ultra and Vulnerable Poor through Poverty Score Card (PSC) around 5 Union Councils Chowk Azam Rural, Layyah thal jandi, Sarishta thal and Laddhana, Jaman Shah. Finally households were passed through a filtration process and 898 ultra and699 vulnerable poor households were selected for various interventions. After filtration of beneficiaries households Livelihood Investment Plans (LIPs) were prepared for 1000 households.

5. Productive Assets

On the Basis of Livelihood investment plans 333 Assets were delivered to the targeted community to lift up them and strengthen them socio-economically. As per the need and identification process Assets were distributed as per below mentioned table.

A collective initiative was also be taken by LSOs for the strengthen of community, people of targeted area have the skills of Marble work, as per their business plan a unit was established in near Layyah city over all 16 beneficiaries were agreed to do the business on the specific terms and conditions.

6. Capacity Building Trainings

On the basis of Livelihood investment plan and selection process of LSOs ADO have been conducted community trainings of 555 persons. The said beneficiaries of trainings avail the training of Enterprise development trainings, Common interest group training, Value chain concept in their business, Skill & vocational trainings. All the beneficiaries are now doing their business / skill & vocational beneficiaries are doing their jobs in their sectors. Especially we would like to mention here that the 6 students are identified for Domestic Kitchen work the training was conducted by Hashoo Foundation in Islamabad. A batch of Art & Carft training was successfully completed by AHAN 20 students are now doing work at their homes with the support of AHAN in Layyah. One batch was completed by the motorway Police school in Layyah 11 students are now doing the job in public private sector with the support of them.

- They learnt the considerations and absorbed the principles that must be applied in a BCE, how to analyze business competency and identify weaknesses.
- The groups had to generate a number of ideas for products and services and screen them according to various criteria.
- They were asked to assess the feasibility of their BCE and announce their expected profit.
- They also had to perform a costing exercise and maintain records of sales and expenses.

- M.Arif says that this training taught them to see their dreams (khwab) and how to plan the 5 years dreams to improve and change their life.

Constraint Faced

• .Mostly participants were illiterate.

Recommendations

 The training material (stationery and books / literature) should be provided from day first of the training.

Production centers

Two production centers were established under the LEED project in the form of collective business. One production center is a *Stitching Unit* which is collectively owned by 20 female members from different villages of two union councils namely Jaman Shah and Layyah Thal Jandi. The other production center is a *Marble Unit* which is jointly owned by 16 male members from four union councils. These are the same asset transfer beneficiaries who have contributed their allocated asset to become part of this collective business. Both of these production centers have started functioning.

In order for making initial assessment of these production centers two focus group discussions were conducted with both type of beneficiary groups. The members of both these CIGs were enthusiastic about the future prospects of their collective business. Many of the members especially females expressed their confidence that their collective business will become their recognition and they will gradually become good business entrepreneurs. Regarding the social impacts of the collective business, many aspects were discussed during FGDs with both male and female beneficiaries. The participants narrated many positive social outcomes as result of becoming part of collective production business such as (i) increased sense of ownership and responsibility; (ii) enhanced competition and cooperation; (iii) increasing trend of sharing problems and helping each other; and (iv) mutual learning and experience sharing.

Market linkages development

As part of LEED Project and other mainstream programs of ADO, there is been considerable activity for developing market linkages for facilitating the poor business entrepreneurs. Under the LEED Project ADO organized a two-day mega event "District Mela". The main objective this event was to attract the project beneficiaries and the government stakeholders and market players for increased interaction and liaison building. The participants had a chance to show their products and services to a wider audience. Different recreational and learning activities were organized during the event. The feedback from different participants shows that the event has been a very successful activity in terms of facilitating the beneficiaries developing linkages with market players.

NYKs

Over all NKYs working under ADO networks registered 998 Beneficiaries were they get Enterprise development training, Skill & Vocational trainings from different training institutes of District Layyah. Some of the student's gets employability with the support of training institutes i.e Hashoo Foundation, AHAN, The Professional training institute, united Collage of Technology.

Two of the NKY Centers registered on the web site developed by the PPAF and students were also registered on it for further activities.

A practitioner of this sport is referred to as a pehlwan while teachers are known either as guru or ustad, depending on their religion. Many southern Indian practitioners of traditional malla-yuddha consider their art to be the more "pure" form of Indian wrestling, but most South Asians do not make this clear distinction and simply view kusti as the direct descendent of ancient malla-yuddha, usually downplaying the foreign influence as inconsequential.


